ABOUT US

Sardar Patel University of Police, Security and Criminal Justice, Jodhpur is established by an Act passed by State Legislature, Government of Rajasthan. To affirm Rajasthan Government's Commitment towards adopting a rights-based approach to address the continuing and emerging challenges in the situation of children, the Sardar Patel University of Police, Security and Criminal Justice (SPUP), established Centre for Child Protection (CCP) in the year 2015. CCP was established with the mandate to be a coordinating link between different departments working for and with the children for creating and promoting just, protective and enabling environment for children, in partnership with the various child rights actors. The Centre has been given opportunity by SPUP to study and examine the relationships between a child and the society. CCP at present, is mainly engaged with issues of Child Rights, Child Protection, the Social World of the Child and Cultural Constructions of Childhood by using several theoretical perspectives and field studies. The Centre has also found that issues of Child Rights and Child Protection have also attracted academia and other sections of the society marginally as far as a comprehensive understanding of these issues is concerned.

Training & Capacity Building

With the view to strengthen the knowledge, attitude and skills of Child Protection functionaries of Rajasthan, CCP-SPUP regularly organizes participatory and interactive capacity building programs in different districts of Rajasthan. Such trainings programs are organized for the Child Welfare Police Officers (CWPOs), Officials from the Special Juvenile Police Units (SJPUs), officials from Anti-Human Trafficking Unit (AHTU), Special Public Prosecutors (SPPs), Station House Officers (SHOs) and Community Liaison Group's (CLG) members. The prime objective of such trainings is to create awareness regarding issues concerning children and to sensitize the participants for dealing in such cases with sensitivity. Centre has designed structured sessions on Child Development, Child Psychology, Implementation of Child Protection Laws (POCSO Act, 2012, Juvenile Justice Act, 2015, Child Labour Act, 1986, etc.). It also covers practical interactions and exposure visits of Child Care Institutions with active facilitation of subject experts in each of the training programs across the State.

Highlights of the Year

- Successful organization of 17 training and capacity building programs on Child Friendly Policing in different Districts of 07 Police Ranges in the year 2019
- Coordination of CCP team with participants and resource persons (especially with CWC, JJB, DCPU, Childline and CCIs for training and home visit)
- About 450 trainees (Child Welfare Police Officers, Officials from Special Juvenile Police Units, Special Public Prosecutors, SHOs and Community Liaison Group members were sensitized from different trainings organized in different Districts of Rajasthan
- Trainings on issues concerning Child Rights and Child Protection were organized in Jaipur, Sawai Madhopur, Chittorgarh, Jaisalmer, Churu and Dhaulpur
- Focus of the training programs was strengthening knowledge, attitude and skills of participants

Detailed Insight of the Trainings

03 Day Training Programme for SJPUs, AHTUs & SPPs from 28th February to 01st March, 2019

The first range level training of the year was organized in Jaipur from 28th February to 01st March, 2019. the participants were the officials from Special Juvenile Police Units (SJPUs), Anti Human Trafficking Units (AHTUs), Child Welfare Police Officers (CWPOs) and Special Public Prosecutors SPPs) on 'Child Protection' issues. The programme witnessed the participation of 47 trainees from different districts of Rajasthan. On the last day, Shri Sunil Dutt (IPS), ADGP-Anti Human Trafficking and Shri R.K. Arora (DIG-BSF), Coordinator- Centre for Peace & Conflict Studies, distributed the certificates to the candidates who had successfully completed the Certificate

course in child protection from Centre for Child Protection (SPUP), Jaipur and to the training participants. The ceremony was followed by unveiling of a pictorial handbook on child sexual abuse titled "SurakshitBachpan" published by the centre.





Training Programme in Sawai Madhopur, Rajasthan from 18th to 21st June, 2019

Training of SJPUs, CWPOs, AHTU Officials, SHOs and CLG members was organised from 18th to 21st June 2019, in Sawai Madhopur district. Sessions in the training covered subjects such as child development & child psychology, principles of JJ Act & its implementation, practical session on preparation of social background report, status of child protection and need for community participation, etc. The sessions were taken by Mr. Umesh Ojha, Add. SP Sawai Madhopur, Ms. Pradnya



Deshpande, Child Psychologist, Mr. Jawed Ansari, UNICEF Rajasthan, Mr. Sameer Kr. Singh, SP Sawai Madhopur and Mr. Dheeraj Verma, Trainer-RPA Jaipur.

Training Programme in Chittorgarh, Rajasthan from 27th to 30th June, 2019

Training of SJPUs, CWPOs, AHTU Officials, SHOs and CLG members was organised from 27th to 30th June 2019, in Chittorgarh district. The trainees were trained on critical issues concerning children such as child rights, UNCRC & constitutional provisions, interactive session on the Child Friendly Policing of



Dungarpur Police, child protection & related laws, to name a few. The resource persons of the sessions were Additional SP- Chittorgarh, Member Secretary- DLSA, Ms. Sindhu Binujeeth, Consultant- UNICEF, Pradnya Deshpande, Child Psychologist, Mr. Jawed Ansari, Consultant-UNICEF, SP Office team, etc.

Capacity Building Program at Churu from 17th to 20th September, 2019

A training cum capacity building programme on 'Child Friendly Policing' was organised for Child

Welfare Police Officers (CWPOs), Officials from Anti-Human Trafficking Unit (AHTU), Special Public Prosecutors (SPPs), SHOs and CLG members from 17th to 20th September 2019 at Churu, Rajasthan. The participants were trained on critical issues pertaining to Child Protection, such as Child Psychology, different Laws related to Child Protection, Issues of Child



Protection like Child Marriage & Child Labour, etc. Ms. Tejaswini Gautam (IPS), SP-Churu, discussed with the participants the key roles of Police personnel in the context of Child Protection.

Capacity Building Program at Jaisalmer from 03th to 06th September, 2019

A training cum capacity building programmeon 'Child Friendly Policing' was organized for CWPOs, AHTU Officials, SPPs, SHOs and CLG members from 03rd to 06th September 2019. The about child Development & Psychology, various Child Protection Laws, Legal framework & remedies etc. were discussed.



The key resource persons for the sessions were Ms. Pradnya Deshpande, Member Secretary-DLSA, Consultant-UNICEF and Mr. Dheeraj Verma.

Capacity Building Program in Dhaulpur from 17th to 19th November, 2019

Three days training and capacity building program was organized at Dhaulpur for Child Welfare Police Officers (SJPUs), Special Juvenile Police Units (SJPUs), Anti-Human Trafficking Units (AHTUs) and Special Public Prosecutors. The rationale of the training was to orient and sensitize the participants about issues related to safety and protection of children. The sessions in the training covered important aspects such as POCSO Act, JJ Act, child psychology and development, etc. The

role of police and channel of referring the child were also discussed. Shri Mridul Kachawa, SP Dhaulpur interacted with training participants and making them aware about their roles and responsibilities, especially in case of children. The resource persons of the training program were Shri Dheeraj Verma, Trainer- RPA, Ms. Pradnya Deshpande, Child Psychologist, and the members of CCP team. Mr. Shakti Singh, Member Secretary, Dhaulpur educated the participants about Victim Compensation Scheme and role of Legal Service Authorities.



Training of CLG Members at RPA, Jaipur on 24th November, 2019

CCP organised a one-day meeting with the CLG members for their awareness generation and capacity building on Child Protection Issues on 24th November, 2019. The roles and responsibilities of the CLG members and challenges faced were discussed. The interaction was also based on the workable solutions in matters pertaining to the protection of children.



Research & Publications

'Research' being one of the core activities, the Centre focuses on conducting analytical studies on different issues related to children. These researches are conducted so as to analyze and understand the actual situation the children are into and pave ways for formulating preventive mechanisms and corrective plan of action. In a short span of five years, the Centre has conducted nine such studies reflecting various aspects of childrens' lives and the way they get affected in different circumstances.

Feasibility Study on Combating Child Trafficking and Bonded Labour in Rajasthan

The study has been conducted with the objectives of describing and estimating the problem, identifying key stakeholders and strategies, and making recommendations for the programme to bring about a measurable reduction of children in the targeted sectors and regions of the state. The study included a detailed desk review of secondary data and interaction with Government representatives in relevant departments, a range of civil society organisations working on related issues, and people who are in bonded labour as well as current and ex-child labourers in different locations in Rajasthan.

Crime Trend under POCSO Act, 2012 in Rajasthan (An Analysis of six Districts)

The research study is based on an assessment and analysis of POCSO cases registered in six districts of Rajasthan viz. Jaipur, Ajmer, Alwar, Jodhpur, Bikaner and Baran. The findings of the study have

been carried out on the basis of secondary data collected from the Police department which include the FIRs, charge sheets, statements of victims, perpetrators and of other stakeholders. These information have been consolidated and compiled. The study brings out the demographic, socioeconomic, profile of the victim and the perpetrator, the circumstances under which the crimes had taken place, etc. It is helpful for the Police Department to understand the essential factors pertaining to crimes of such nature, strategise the preventive measures and plan the corrective course of action.

Research Study on Care & Protection of Children of Women Prisoners in 9 central prisons of Rajasthan

The study will help key stakeholders to understand the situation of the children of women prisoners (their daily routine of life in prison, services available for their care, protection, health, education and development, interactions with the inmates and administration of the prison, contact with the outside world, family members and relatives, etc and problems/challenges faced by children, women prisoners and concerned authorities on a regular basis). The findings of study and recommendations will contribute towards addressing their long-term problems they encounter after release from prison like; life-long stigma of living in prison, difficulty in adjusting with other siblings and family members, attention seeking behaviour of children, difficulty in understanding and distinguishing different relationships, inability to recognize relatives, socializing with other children of the same age group and making friends.

Rehabilitation of Children in Conflict with Law

The purpose of the study is to understand the actual status of rehabilitation prevalent under the juvenile justice system and to find ways of further strengthening the rehabilitation and reintegration of Children in Conflict with the Law (CICL). In the study, attempt of examining the rehabilitative measures undertaken for the children within the juvenile justice system and examining the perspective of the adults about the children and their rehabilitation has been made. Study also analyses the secondary data on Juvenile Delinquents from NCRB portal and published sources from 2011 to 2016. Study findings and recommendations highlight aspects of administration of observation homes and place of safety, deployment of trained human resources, contact of children with the outside world, family members, relatives, etc., It is expected that, the study will help key stakeholders to understand status of rehabilitation of CICLs in CCIs and existing gaps, quality of skill development programmes implemented for CICLs and level of engagement of facilitators/experts, participation and interests of CICLs in reformative programmes, challenges faced by CICLs, facilitators/experts and concerned authorities.

Mapping of Critical Services and Needs of the Residents especially of Children in Open Air Camp, Sanganer, Jaipur (Rajasthan)

The purpose of the study is to prepare mapping of services provided in open jail and their relevance or impact, mapping of critical developmental service needs of the residents (families and individual) of open jail, Sanganer, Jaipur specially focusing on the needs of children and women, to examine the level of satisfaction/content of the residents about received facilities in open jail, mapping and analysis of collected data on children of prisoners living in open jail. Also to come up

with recommendations for planning and execution of customized interventions to meet out individual needs and carry out the opinion/view of respondents and their concerned officials about life in jail v/s Open Jail (correctional facilities).

Study of Internet Usage Pattern Among Urban Adolescents in Rajasthan

This study has been conducted in order to find out the internet usage pattern of the adolescent population of Jaipur city. Since internet is dominating the human race in the present times, it has become specially important to know how the adolescents falling in the age group of 14 to 16 years are using internet, what activities they are indulged in, how much time they spend on the web in various activities, their presence on the social media, etc. This research would enable us and all Child Protection and Mental Health functionaries to understand the web-psyche of the adolescent school goers and figure out the needs and requirements of not only the current times, but also of the time to come in terms of the holistic welfare of the adolescents.

Making Strong FIR & Charge Sheet for Increasing the Conviction and Mainstreaming the Child Labour Survivors in the Society

The study aims to identify major issues and gaps to provide recommendations on the FIR and Charges Sheets pertaining to child labour, particularly hazardous work for minors, and possible approaches to effectively and strong FIR and Final report. It is helpful in the development of understanding on writing strong FIR, conviction in the child labour cases and mainstreaming the child labour survivors in the society. The study report provides an overview of the child labor cases reported in Jaipur north region, quality of FIRs and Charge sheets written and filed in the cases, time taken in the investigation process of the cases as well as the recommendations to improve the quality of strong FIRs and Charge Sheets for increasing conviction rate in child labor cases. It also sensitizes the police personal, line departments and related stakeholders about the situation of the children involved in child labor and how they are exploited, how the accused and traffickers are breaching off their rights. The report also provides objective recommendations for doing necessary efforts to stop the child trafficking and child labor.

Vulnerability Assessment of Child Labour in Bihar and Rajasthan

The study has been conducted in Jaipur and Udaipur in Rajasthan and in Gaya, Bihar, to assess the vulnerability of child labour. The objectives of this study are to factors responsible for children to get into the trap of trafficking, difficulties faced by the children vulnerable to child labour, Government's perspective in handling the gaps in child labour cases and to propose potential policy/program measures that consider holistic economic and social factors to prevent children becoming vulnerable to trafficking and child labour.

My Safer Jaipur: Rapid Assessment Analysis

This study has been conducted by The Jaipur Police Commissionerate in partnership with Centre for Child Protection with support from UNICEF. It has been attempted tp find out how safe or unsafe, the residents of Jaipur city feel at different public places in the city viz. home, school/colleges, work, public spaces, public transport, on the road. It also includes the analysis of online safety aspects. Questionnaires for this purpose were filled through online medium and physical data collection.

Publications of the Year

Four editions of the quarterly newsletter 'SETU'

The centre releases a thematic quarterly newsletter 'SETU'. Each newsletter comes with a different theme, revolving around the issues of Child Rights and Child Protection. The newsletter educates the stakeholders on several issues, presents the details of all activities conducted at the centre in each quarter, case studies, articles, etc. In 2019, the newsletters were rolled out on themes such as Childhood Against Violence, Child Abuse and Neglect, Children in Substance Abuse and Child Trafficking.

Content & Course Development

Highlights of the Year

- Revision and relaunching of Online Course in Child Protection
- Commencement of third batch of Certificate Course in Child Protection: 20 participants took the course
- Conduction of Convocation Ceremony for Certificate Course in Child Protection (CCCP) for batch 1 & 2 conducted on 01st March, 2019 at Rajasthan Police Academy, Jaipur. 29 course participants were awarded certificates and marksheets
- Conduction of three Board of Studies (BoS) meetings for developing, reviewing, refining and finalizing the syllabus, course curriculumand rules and regulations for Post Graduate Diploma in Child Protection (PGDCP), Certificate Course in Child and Adolescent Counselling (CAC) and Certificate Course in Child Protection (CCCP)
- Master in Social Work (MSW) Course: Centre is also working on the MSW Course with specialization in Child Protection. Coordination was done with Sardar Patel University of Police, Security and Criminal Justice, Jodhpur regarding the course related modalities and other formalities. Initial formalities for the launch of the course have already been done
- Rigorous efforts in terms of Course syllabus review meetings for making Certificate/ Diploma Course in Child & Adolescent Counseling (CAC) Course more comprehensive, practical and need based for the maximum benefit of the course participants

Commencement of Certificate Course in Child Protection

CCP in collaboration with SPUP and UNICEF conducted the first contact class of 2019 batch of Certificate Course in Child Protection at Intelligence Training Academy, Jaipur on 15th & 16th June, 2019. The classes



began with a brief round of introduction, facilitated by CCP team. The lectures were taken by Shri Radhakant Saxena, Rtd. IGP- Prisons, Mr. Anshuman Saxena, Advocate- Rajasthan High Court, Ms. Pradnya Deshpande, Child Psychologist & Social Activist, Mr. Jawed Ansari, Consultant-UNICEF, Ms. Sandeep Kumar, Assistant Director- Social Welfare Department and Dr. Rajeev

Gupta, Retd. HoD-Sociology, University of Rajasthan, Jaipur. The classes were taken on concept & framework of human rights, Indian Constitution, UNCRC & other international conventions, child rights & their redressal, types & situation of special children and issues concerning displacement.

Subsequently, regular classes were conducted till November, 2019.



Online Certificate Course on "Basics of Child Protection"

The Centre for Child Protection is running an online course named "Basics of Child Protection" for all interested aspirants who are working in the field of Child Rights as well as other enlightened people through distance learning method. The aim of this course is to raise awareness on Child Rights and to contribute towards an enabling safe and child-friendly environment. Following are the objectives of the online Course:

- To create awareness on basic knowledge of Child Rights and Child Protection and to contribute towards an enabling safe and child friendly environment for children in all areas of society.
- To access the basic knowledge on child protection by the registered viewer, anytime and anywhere through online procedure.
- To develop a brief knowledge on Child Rights and United Nations Convention on Rights of the Child (UNCRC).
- To understand the concept of Childhood and Child Development
- To explore the understanding of some forms of violence, exploitation and abuse that child experiences and/or are at risk of facing and
- To understand different forms of child protection mechanisms to safe-guard the rights of children.

This e-course is designed in the form of self-study material and has four modules (116 PPT slides)

which will take approximately 2 hours for the registered viewers including self-assessment that will be taken to assess one's understanding of each modules. Each module of the course will enhance the knowledge of child protection gradually. Persons of any age-group can apply for online registration on https://centreforchildprotection.org/online/.

Following are the four modules of the Online Course on "Basics of Child Protection":

- Module-1: Introduction to Child Rights
- Module-2: Childhood and Child Development
- Module-3: Child Protection: Issues and Concern
- Module-4: Child Protection Mechanisms

The registered student who completes the course can also obtain a certificate that is generated automatically after making a payment of Rs.100 to CCP account through online process. Till date, more than six hundred candidates have successfully completed the course.

CERTIFICATE /DIPLOMA COURSE IN CHILD AND ADOLESCENT COUNSELLING (CAC)

Centre for Child Protection (CCP), Sardar Patel University of Police, Security & Criminal Justice (SPUP), has launched 'Certificate / Diploma Course in Child and Adolescent Counselling'. This programme is designed to operate on the 'Walkout Procedure' mode. Thus, following curriculum scheme will be followed:

- 06 months for Certificate Course (One semester of six months)
- 01 year for Diploma Course (Two semesters each semester of six months)

After the completion of this programme, the learner will be able to understand the nature and personality of children of different categories and the complexity of childhood. Learner will understand the problems and issues which a child faces in this complex world. The learner will acquire those skills by which a child/adolescent counselling could take place effectively. The content structure of the course will encourage learner to have effective and emotional interface with children. Such interface will provide opportunities and spaces through which learner could help children for entering into resocialization process so that they could get functional space in the society. This programme also provides proper understanding about those legal mechanisms by which crisis faced by children, could be addressed. It also helps to understand the appropriate rehabilitation processes and mechanism for children who need psychosocial support. This course is planned as per CCP's objective to run the mainstream courses on the issues which are impacting the lives of children with focus on child protection. The number of participants will be decided as per the demand for the course, but the number of participants in one batch will not be more than 50. This course will be run in distance mode, in which contact classes and orientation of participants will take place.

Liaison & Advocacy

Training Sessions at Rajasthan Police Academy

CCP has actively been facilitating training sessions at Rajasthan Police Academy. Team members have taken more than several sessions on varied issues related to Child Rights, Child Protection, Child Sexual Abuse, Prevention of Children from Sexual Offences (POCSO) Act, 2012, Juvenile Justice (Care & Protection of Children) Act, 2015, Child Labor, Child Marriage, Beggary, Safety of Women at Workplace, etc. More than 500 participants comprising of Police officials from different regions of Rajasthan have been trained by CCP staff. More than 20 such sessions have been taken.



Training Session in the Interface Program Organised by Plan India Under 'Let Girls be Born Project'

CCP was represented in the interface cum exposure organised by Plan India in collaboration with its grassroot partner SRKPS. It was aimed at helping to reach out to the organizations working for women's issues and girl child survival and Protection and would provide a chance to peer educators for Knowledge building on how these Structures and Institutions can provide support in addressing the gender inequities in the society within the context of gender





biased sex selection and girl's protection. The interface took place on 10th June, 2019 and the participants were the representatives of One Stop Crisis Centre, MSSK, Mahila Thana, CWC, BBBP along with several young peer educators.

- Meeting with University of Rajasthan for development of CAC Course and possibilities of MoU for running CAC Course in respect to using their lab for conducting various tests

Child Labour Free Jaipur Initiative

Thousands of children are working as child labourers in workshops in Jaipur. They are engaged in making bangles, embellished textiles and even polished stones for jewellery. The Child Labour Free Jaipur Initiative is embarking on comprehensive interventions to stop child labour in the Pink City.

With strong support from the Rajasthan state and local governments, Jaipur will be showcased as a city with an unprecedented commitment to ending child labour. It is trying to serve as a model for other cities to follow under the Child Labour Free Jaipur (CLFJ).

Apart from Government support Freedom Fund is working with leading businesses, industry associations, local organizations, law enforcement, funding agencies and child rights experts, including center for child protection, Sardar Patel University of Police, Jaipur the Initiative has a united strategy to target the root causes of child labour to make to Jaipur Child Labour Free Initiative.

Trainings Conducted

02 Days Training on Safeguarding the Prevention, Rescue and Rehabilitation of Child Labour and Trafficking Cases for SJPUs, AHTUs, GRPs and CWOPs

Two days training programme (14th-15th March, 2019) was organized for the members of Special Juvenile Police Unit (SJPU), Officials from Anti-Human Trafficking Unit (AHTU), Government Railway Police (GRP) and Child Welfare Police Officers (CWPOs). The basic objective of the training was to encourage the 'child friendly attitude and understanding' among the Police officials dealing with the cases of child labour. The focus of the training was on establishing systematic guidelines to



undertake Police trainings in a skilled manner through all its various stages. An attempt was made to make it comprehensive and highly interactive for the exchange of notes and field experiences. The total number of participants of this training were 54 including those from Child Care Institutions.

Training of Counselors on 'Counseling of Children'

The training was conducted from 23rd to 24th April, 2019 for the staffs of Child Care Institutions. The event saw the participation of 35 trainees including Counsellors, Case Workers, and

Superintendents from shelter homes & a Government Children's' home, Freedom Fund Representatives and individual counsellors. The participants were trained on dealing with children and ensuring proper counselling before initiation of the process of rehabilitation and repatriation. The prime objective of the training program was to enhance clarity on counselling skills, documentation, networking and preparedness for case management, rehabilitation, re-integration of shelter



homes children especially child labour, roles and responsibilities of Shelter home personnel, etc..The programme was addressed by Shri Nishkam Diwakar, Director, Department of Child Rights, Jaipur. The key resource persons of the programme were Shri Ashwin Sharma, Assistant Director, District Child Protection Unit, Department of Child Rights and Social Justice and Empowerment Department, Government of Rajasthan, Dr. Pradnya Deshpande, Child Psychologist and Ms. Kavita Magnani, HAQ, Delhi.

Training of AHTU and SJPUs on Ensuring Prosecution and Conviction of Traffickers at Patna, Bihar



A Training program on Anti-Human Trafficking Units and SJPUs on ensuring prosecution and conviction of traffickers/employers" was organized on 16th and 17th July, 2019 at Patna, Bihar. Total 47 police personnel from different Departments viz. Anti-Human Trafficking Units (AHTUs), Deputy Superintendent of Police and Special Crimes, Police, members from Justice Ventures International (JVI), Prayas, Human Liberty Network (HLN) were attended the workshop and included Resource Persons, Freedom Fund representatives, CCP Team members participated

in the training program. The objectives of the training programme were to orient the partricipants on the due procedures before law including existing laws i.e. IPC, CrPC, child trafficking and labour laws, guidelines, SoPs and Government orders. Another major objective of the programme was to develop the understanding on writing strong FIRs and chargesheets particularly on the issues related to Child Protection and to combat child labour and develop coordination between States (Bihar: Source and Rajasthan: Destination). It was brought forward that CCP-SPUP is promoting protective and enabling environment for children in partnership with various child rights stakeholders and also work as knowledge hub and resource agency for child protection and child rights. An effort was made to understand the entire process and nexus of child labour.

Consultation with Lawyers and Public Prosecutors on Ensuring Prosecution and Conviction of Traffickers

A Consultation with Lawyers and Public Prosecutors was organized on 26th July, 2019 at Hotel Vesta International, Station Road, Jaipur. It was on ensuring prosecution and conviction of

traffickers/employers in cases of child labour. The programme witnessed a participation of 50 representatives from District Legal Services Authority (DLSA), Public Prosecutors, UNICEF, Freedom Fund, Taabar, Prayas, etc. The consultation was organized with support from Freedom Fund. The objectives of the consultation were to orient the lawyers regarding the situations& challenges of conviction of child labour cases and to discuss salient features of Rajasthan Victim



Compensation Scheme and Central Sector Scheme for Rehabilitation of Bonded Laborers, 2016.

Consultation with Judiciary on the Conviction of Traffickers/ Employers in Cases of Child Labour

A Consultation with Metropolitan Magistrate, Additional District Judges and concerned Stakeholders was organized on 1st September 2019 to ensure the conviction of traffickers/employers in the cases of child labour. Around 70 participants from District Legal Services Authorities, Child Welfare Committee, Labour Department, Education department, Anti Human Trafficking Units, Taabar, Prayas, and Freedom Fund participated in the consultation. The consultation was organized in close collaboration with District Legal Service Authority (DLSA),



Jaipur with support from Freedom Fund. The discussion was majorly focussed on the current status of the child labour cases in Jaipur and in India, at large. The implementation of Child and Adolesent Labour (Prohibition and Regulation) Amendment Act, 2016 was also discussed.

Capacity Building Program of Labour Inspectors on Ensuring Entitled Compensation to Rescued Children and Take Preventive Measures

One day training program for labour inspectors and other concerned officials was organized on 21st September 2019 for capacity building of in-service labour Inspectors and other concerned officials

on developing strategies to be involved in District Child Labour Task Force, to ensure entitled compensations to the rescued children and take preventive measures. The programme witnessed a parrticipation of about 35 participants from Labour Department. The training was organized in collaboration with the Department of Labour, Rajasthan. The key resource persons of the programme were Dr. Helen R. Sekar, Senior Faculty Member, V.V. Giri



National Labour Institute, Delhi and Dr. Onkar Sharma, Deputy Chief Labour Commissioner Central, Ministry of Labour and Employment, Government of India. The sessions were focussed on existing situation and understanding of child labour in Rajasthan focusing specifically on the statistics, category, magnitude and efforts being exerted by the stakeholders. The concept of labour laws as stepping stone for creating Child Labour Free India was also discussed in addition to a participatory session on 'Right of Children to free and Compulsory Education' in context of eradication of child labour.



Training of North AHTU and CPWOs on Ensuring Prosecution and Conviction of Traffickers

A number of meetings have been conducted throughout the year with the Additional Commissioner of Police & Deputy Commissioner of Police North with regard to ensuring prosecution and conviction of traffickers. Another important agenda of the meetings was to strengthen the FIRs pertaining to Child Labour Cases. Police officers also, were the participants in such meetings so as to build a local team to work strongly on combating this 'issue of concern'.

Other Initiatives Taken Under the Freedom Fund Project

Divisional Level Workshop on Child Labour and Child Trafficking

A training with Metropolitan Magistrate, Additional District Judges and Concerning Stakeholders was organized on 22nd December 2019 to ensure the conviction of traffickers/employers in the cases of child labour and child trafficking at Zila Prishad, Banipark, Jaipur. Around 110 participants from District Legal Services Authorities, Child Welfare Committee, Labour Department and Anti Human Trafficking Units participated in the training program. The consultation was organized in collaboration with District Legal Services Authority with the support of Freedom Fund and UNICEF, Rajasthan.

Meeting with School Management Committee

Support provided to the Education department for conducting the School Management Committees meeting with North members. The meeting was held from 26th to 27th November 2019 at Dwarikapuri, Shashtri Nagar. Around 120 SMC members participated in the meeting. The participants were oriented on the issues of prohibition of child labor, exploitation of children, drop out rate of children and information dissemination on IEC material focussed on child labour titled 'Baal Shram Mukt Bachpan'.

Strengthening of Child Labour Task Force

Representation of CCP in the District Child Labour Task Force meeting organized by the Labour department at Collectorate, Jaipur on 11th October, 2019. Support provided to the labour department for conducting training programme of Labour Inspector/ Sub Divisional Magistrate (SDM) and Police Personnel. The training programme held on 16th October 2019 at Rajasthan Police Academy, Jaipur, witnessed around 70 participants from the said departments.

Handholding Support to Shelter Homes

Intensive visit have been done by CCP staff at selected shelter homes of Jaipur for providing hand holding support to the children and staff regarding strengthening the 'Children Committee' and 'Management Committee'.

Orientation Programme of Counselors

Orientation programme for the counselors was also organized by CCP focusing on effective counseling of 'children in need of care & protection' at One Stop Management Crisis Centre, Gandhi Nagar, Jaipur.

CCP in collaboration with ICMEC, in coordination with GCCT and partnership with Rajasthan Police Academy, organized four days international training programme on "Online Child Sexual Exploitation Investigations" from 03rd to 06th June, 2019 at Conference hall of Rajasthan Police Academy, Jaipur. This course was designed for Investigating officers, child protection functionaries of Rajasthan, including Special Juvenile Police Units, Anti-Human Trafficking Units, cyber cell of Rajasthan Police and faculty of SPUP. The resource persons of the event were from ICMEC, Google, Queensland Police Service, Australia, Louisiana State



Police, Canadian Law Enforcement Agency, Felony Division- Leon County State, Jordanian National Police, Kerala Police, Karnataka Police, etc., to name a few. The event witnessed participation of 90 representatives from target groups.

Training and Orientation on the Safe School Programme at Jaipur

A one-day training on 'Safe School Programme' was conducted on 09th August 2019 at Rajasthan Police Academy, Jaipur. The participants represented the Police Department, NSS, UNICEF and Rubaroo, Gujarat. The objective was to sensitize the police personnel



about various aspects of safe schooling. Sessions were facilitated by Child Psychologist Mr. Deepak Teraiya and Mr. Dheeraj Verma, Trainer-RPA.

Exposure visit of Girls to Rajasthan Intelligence Training Academy, Jaipur

An exposure visit to Rajasthan Intelligence Training Academy was facilitated by CCP to SRKPS. SRKPS in collaboration with Plan India is implementing a project called "Safer Cities" in Jaipur in order to enable safe environment for women and girls, the



aim of which is to ensure safety of women at all public spaces and in the public transport. This is because women often face sexual harassment and violence in the public spaces. In this context, two exposure visits were organized for 30-35 girls on 25th May and 17th June, 2018.

Session on 'Restorative Justice' at CCP Jaipur on 19th September, 2019

An interactive and enlightening session on 'Restorative Justice' was conducted at the Centre. Mr. Robert Van Pagee, Director- OP KleineSchall, a Dutch NGO, has visited the Centre to share with CCP team the insightful thoughts on the concept. He also discussed about the best practices adopted in the Netherlands and New Zealand. All faculty members of CCP participated in the discussion.

New Year Celebration

Team CCP, Jaipur celebrated New years' day on 01st January, 2019 with the children in Government run children's home at Sethi Colony, Jaipur. There were 40 children who were in need of care and protection and 59 of those who were in conflict with law. Cake cutting was done, story books & educational books were distributed to the children along with board games. Certain activities like singing competition, storytelling, enactment & role play, etc. were also organized for the children.

Celebration of children's week (14th-20th November, 2019)

CCP celebrated Children's week in different institutions. Different programs were organized on 14th Nov., one of which was a debate competition. It was organized in Kanoria Girls PG College wherein 200-250 girls participated. The theme of the debate was 'Baal Sanrakshan kiski Zimmedari- Rajya ya Samaj'. In another program of the day, an interactive session was organized on 'child protection and role of police' at RPA, Jaipur. Mr. Sanjay Nirala, Child Protection Specialist- UNICEF had an interaction with the participants and issues concerning the protection of children in the
